Town Board Member **Perticone** offered the following resolution and moved its adoption:

WHEREAS, the State of New York Department of Transportation requested the Town of Irondequoit review the Local Highway Inventory (LHI); and

WHEREAS, the Department of Public Works last updated the LHI pursuant to resolution 2016-281; and

WHEREAS, the Commissioner of Public Works has deemed it necessary to correct two errors are noted within resolution 2016-281, specific to the name of a certain roadway; and

WHEREAS, Huntington Hills Center is a roadway that begins at the Dead End and ends at Wisner Rd., which measures .60 miles, and is owned and maintained by the Town of Irondequoit; and

WHEREAS, Dogwood Lane is a roadway that begins at Huntington Hills Center and ends at the Dead End, which measures .13 miles, and is owned and maintained by the Town of Irondequoit;

WHEREAS, the New and Extended Road Template worksheets and associated maps for each roadway, has been completed by the Commissioner of Public Works and are attached to this resolution.

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Irondequoit requests the State of New York Department of Transportation amend the Local Highway

Inventory to include the roadways listed in this resolution and included in the New and Extended Road Template worksheets and associated maps for each roadways attached hereto.

AND FURTHER IT BE RESOLVED, that this resolution amends and supersedes Resolution 2016-28 solely to the extent that Resolution 2016-28 pertains to Huntington Hills Center and Dogwood Lane.

This resolution shall take effect immediately upon its adoption.
